

THE DINK TANK MEMBERSHIP AGREEMENT

This Membership Agreement (“Agreement”) is a legally binding contract between **The Dink Tank, LLC** (“The Dink Tank”) and you, the undersigned individual (“Member”). This Agreement governs your access to and use of The Dink Tank’s facilities, courts, leagues, tournaments, coaching, and events.

By purchasing a membership, you acknowledge and agree to the following terms and conditions:

1. USE OF FACILITIES & SERVICES

- Membership grants you access to The Dink Tank’s **indoor pickleball courts, leagues, tournaments, events, and coaching services** as outlined in your membership benefits.
- You agree to use the facilities for **personal, non-commercial use** and comply with all **facility rules, regulations, and local laws**.
- Court reservations, event participation, and coaching sessions are subject to **availability and scheduling policies**.

2. CODE OF CONDUCT

- All members must adhere to **The Dink Tank’s Code of Conduct**, ensuring **sportsmanship, integrity, and respect** for fellow players, staff, and guests.
- Violations of the Code of Conduct may result in **membership suspension or termination** without a refund.

3. MEMBERSHIP TERMS & BENEFITS

The Dink Tank offers two membership options: a **Monthly Membership** and an **Annual Membership**, both of which automatically renew unless canceled as outlined in Section 5. Memberships are non-transferable, and pricing is subject to change with notice.

Membership Benefits (Applicable to Both Monthly & Annual Memberships):

- **24/7 access** to The Dink Tank facility
- **14-day advance booking windows**
- **Reserve up to 4 hours at a time**
- **Easy court splitting** through our app
- **Early access** to leagues, tournaments, and events via our app
- **Discounts** on league play

- **Discounts** on open play nights
- **Access to member-only events** and community perks

Membership benefits are subject to change at The Dink Tank's discretion.

4. START DATE & RENEWAL

Membership begins on the date of purchase and will **automatically renew** on a monthly or annual basis, depending on the selected plan.

Members will be notified in advance of any pricing or membership changes.

5. CANCELLATION & AUTOMATIC RENEWAL TERMS

Monthly Memberships:

- Require a **minimum 2-month commitment**.
- May be canceled at any time **after the initial 2-month period**.
- To avoid being charged for the next billing cycle, cancellations must be submitted **at least 30 days** before the next renewal date.
- If canceled and rejoined at a later date, the **\$47 initiation fee** will apply and previous rates may not be guaranteed.

Annual Memberships:

- You may cancel within forty-eight (48) hours of your Start Date for a full refund.
- After that period, your **Annual Membership is non-refundable**.
- If you do not wish to renew, cancellation must be submitted at least **30 days** prior to your renewal date.

The Dink Tank reserves the right to cancel, suspend, or revoke membership privileges at any time for violation of facility policies or rules.

6. PAYMENT TERMS & AUTHORIZATION

- Members must maintain an **active payment method on file** (credit/debit card or ACH).
- By signing this Agreement, you authorize The Dink Tank to **charge your selected payment method** for monthly dues, reservations, purchases, and any applicable fees.

- If a payment is declined, The Dink Tank reserves the right to **suspend membership benefits** until the issue is resolved.

7. LIABILITY WAIVER & ASSUMPTION OF RISK

- Members **assume all risks** associated with participation in pickleball and related activities.
- The Dink Tank is **not liable** for injuries, accidents, or lost/stolen property.
- Members must sign The Dink Tank's **Waiver of Liability & Release Agreement** before participating in any activities.

8. ELIGIBILITY & COMPLIANCE

- All members must comply with **The Dink Tank's policies, facility rules, and safety regulations**.
- Failure to adhere to these policies may result in **suspension or termination of membership**.

9. MODIFICATIONS TO TERMS

- The Dink Tank reserves the right to **modify membership benefits, pricing, and policies** at any time.
- Members will be notified of significant changes via email or posted notices at the facility.

10. ACKNOWLEDGMENT & AGREEMENT

By signing this Agreement, I acknowledge that I have read, understood, and agree to the terms outlined above. I further agree to abide by The Dink Tank's policies and Code of Conduct, and I understand that any violations may result in the suspension or termination of my membership.
